SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Acute toxicity, oral and inhalation (Category 4). Harmful if swallowed or inhaled (H302+332). Do not eat, drink or smoke when using this product (P270).



Hazard class: Sensitization, skin and respiratory (Category 1). May cause an allergic skin reaction (H317). May cause allergy or asthma symptoms or breathing difficulties if inhaled (H334).

SECTION 4 — FIRST AID MEASURES
